BOND SCOPE

- CHS Parking Lot
 - o Will be "substantially complete" next week
 - o ADA parking spaces and lighting contribute to "Safety & Security"
 - o Softball batting cage relocated and improved (not bond funded)
- District-wide Door Hardware Replacement
 - o More secure key control going forward
 - o Phase 1 complete at JES, SVE, PES, SMS and HMS
 - o Phase 2 is under way at CPE, MRE and CHS
 - o Phase 3 to take place next summer: select door replacement
- District-wide Lighting Upgrades
 - o Financed through Senate Bill 1149 and future energy savings (not bond-funded)
 - o Will be complete this month
 - o Less District maintenance in the future
- CPE Boiler Replacement and Direct Digital Controls (DDC)
 - o Replaced aging boilers
 - o DDC's allow staff to track and control HVAC remotely
 - o DDC's create a more energy-efficient system
- JES New Building

- o Construction has started: rock base going in
- o Site safety has been addressed
- o Target GMP was met
- MEP Upgrades at JES, MRE, SVE and PES
 - o Design team completed 100% Design Development documents
 - o Held 100% DD review meeting
 - o Contractor and professional estimates are under way
- ELC
 - o Design Team is in Construction Document phase
 - o Expecting General Contractor estimate December 18th
 - o Design refinements is continued

 - Not planned for this time.
 - o June Brock: Has COVID affected schedule?
 - No significant delays thus far.
 - o Bret Moore: Has not experienced delays in his construction practice.
 - o Sam Steele: Appreciate parents of school age kids participating in today's meeting.
 - o Sam Steele: Budget talk in January will cover how funds are being stretched.
